D. Meeting of the Board of trustees.

- There shall be a clear five days notice of the meeting and in case of emergency the secretary/managing trustee shall be entitled to call for special meeting of the trustees with 24 hours notice.
- All decisions shall be by means of resolutions of the majority of the trustees present and voting.

E. The Powers and Functions of the Board of Trustees:

- (1)The Board of trustees shall elect amongst themselves the office bearers of the trust for every two years.
- (2)There shall be a president/managing trustees/secretary.
- (3)The Board of trustees shall have the powers to open any number of branch of offices of the trust at any place to carry out the programmes of the trust.

- (c) If he declared insolvent by any competent court of law.
- (d) If he is convicted for any criminal/ or turpitude by competent court of law.
- (e) If he does not attend three consecutive meeting of the board without furnishing the proper and satisfactory reasons to the majority of the trustees in the board.

5) RIGHTS AND DUTIES OF THE TRUSTEES:-

1. The trustees shall deem to be the member of the trust for life time unless he/she tenders his/her resignation to the office of the trustee.
2. The trustees shall have the right to participate in the meeting of the board of trustees and also over the assets and properties of the trust.
3. The trustees shall have the powers to designate any person of the choice as nominee.
4. The nominee shall inherit all the rights and privileges of the original trustee.
5. In the absence of the nominee the legal heirs of the trustee shall inherits the rights and privileges of the original trustees.
6. When a trustee is disqualified on any of the grounds mentioned under Colum 5(e) a or b or c, the nominee of the
