Child care institutions - We have successfully provided care and protection to 32 children who are underprivileged including orphans/semi-orphans. We have started foster home for the 8 boys(english medium)

Shishupalana Kendra -We have nurtured 25 children in the 0-6 age group through our day care services, with a majority of them being children of working women.

CSR activities - Through a collaborative effort with NESS digital engineering company, we have successfully undertaken CSR activities that have resulted in significant improvements. Notably, we have constructed a separate kitchen for boys, established a dedicated dining hall, and successfully set up a computer lab.

Amid the COVID-19 pandemic, we strategically targeted select villages to educate residents about COVID-19 prevention measures.
