## **Formation of JLG's (Joint Liability Groups):**

In this year 2017-18 The NABARD Regional office Bangaluru sanctioned 100 JLG's in our project area Koppal dist. According to their suggestions & guidelines we formed 116 JLGs in our project area. Now the entire JLGs well organized & started weekly savings also. Each JLG saved Rs.2000/- to Rs.3500/- in this year Totally 3, 48000/- . Now we linked NABARD Micro Finance to develop local lively hood activities (sarree Business, vegetable wending, Tailoring, petty Business, Bangle Business & agriculture product process). The NABARD Micro Finance giving loans to all the JLG members. Each member taking 30000/- to 50000/- per enterprises & lively hood activities totally 1, 25, 00,000/-giving the loans.



## Self Help Group Training:



During this year we conducting several subject oriented Training Programs to 65 self Help Group women's in Koppal Dist. With the help of agriculture Department – PMKSY- WD- IWMP 3 & 4 Batch. Totally 526 women's are participated & getting the benefit.

## Natural Resource Management:



The NABARD RO office sanctioned 1 watershed program in Koppal dist. To develop the 951 hector of land development activities & environment development programs covering 570 families consist of 4 villages. In this project we are giving awareness on climate control activities & plantation of different seedlings in the farmer's field bunds.

## Grama Sabha:



During this year The NABARD Watershed project area villages namely Mettagal, Jinnapura, Jinnapura Thanda, D. Hosalli. We are conducting the regular Grama Sabha in all the villages with the participation of farmers SHG members & Panchayath raj members. In the GramSabha we discussed present & future plans of programs.

During this year we conducting awareness program in all the project area villages' trough cultural activities to develop the Natural Resource Management & its important totally 2625 participants are attending in this program.
